

Greetings from the WFMT President, Ms. Vivian Chan





- Initiated contact with music therapists affected by the emerging Israel-Gaza crisis to assess their situation and extend support in line with GCIC's vision and WFMT's mission to promote global music therapy through information exchange, collaboration, and action.
- Held meetings and discussions with a Middle East advisor and anti-terrorism expert on initial strategies for addressing the delicate situation in the Israel-Gaza crisis in preparation for WFMT's GCIC work.
- Explored the feasibility of supporting fundraising efforts for humanitarian assistance (medical supplies, food, and water) to civilians caught in the Israel-Palestine crisis, following United Nations recommendations.
- Collaborated with the WFMT President to create an October Buzz notice and other social media posts to contact music therapists affected by the Israel-Palestine crisis.

- Initiated contact with the European Confederation of Music Therapy and worked with the Eastern Mediterranean regional liaison to document and relay the lived experiences of music therapists affected by the Israel-Gaza crisis to the WFMT Council.
- Facilitated initial discussions with Jewish music therapists from North America and Israeli music therapists under the ECMT to convey their needs to the WFMT Council.
- Chaired 12 meetings with the WFMT GCIC to prepare educational resources (informational handouts, videos, etc.) focusing on reducing trauma symptoms and promoting coping and resilience for WFMT members and their communities worldwide.
- Communicated with contacts in the Ukraine war crisis and extended GCIC educational and trauma coping resources in response to the ongoing war.
- Coordinated with Ciele Knox of the NICU Institute at Florida State University to explore providing specialized NICU support to premature infants affected by the Ukraine War Crisis.
- Revisited and refined GCIC's scope of practice to ensure alignment with WFMT's mission and recent project developments during the first year of the new term.
- Assisted WFMT Officers in evaluating and addressing public concerns submitted to WFMT and participated in discussions with other music therapy professional organizations as a follow-up to council meeting requests.
- Updated WFMT's social media platforms (Facebook and Twitter) to seek music therapists affected by crises worldwide on behalf of the GCIC.
- Responded to various email and social media inquiries related to music therapy, crisis intervention, and the WFMT.

Ongoing Activities

- Answered calls to assess the needs of music therapists affected by flooding in Brazil and determined the scope of support the WFMT GCIC can extend (newly initiated, ongoing).
- Recorded videos and translated informational handouts and other materials on trauma reduction and coping resilience into several languages to cater to global music therapists' needs.


